




The South District Plan has identified Collaboration Areas and Strategic Centres that will play a major part in the success of the region over the next two decades. The South District comprises the local government areas (LGA's) of Canterbury-Bankstown, Georges River and Sutherland.

Collaboration areas include Australian Nuclear Science Technology Organisation (ANSTO), Education and Health Precincts and Bankstown Airport and Milperra Industrial Area.

Strategic Centres







Collaboration Areas

The South District Plan states Collaboration Areas are:

"a place-based process led by the Greater Sydney Commission to address complex issues that require cross-stakeholder solutions. This will be undertaken by identifying and aligning the activities and investments of government and stakeholders, based on evidence, to deliver significant regional and district livability, productivity and sustainability outcomes" (South District Plan, p. 20)

Australian Nuclear Science Technology Organisation

The Australian Nuclear Science and Technology Organisation (ANSTO) Research and Innovation Precinct at Lucas Heights contributes significantly to the local economy with approximately 1,000 employees. ANSTO is anticipated to be a major draw card for enterprises (small to medium sized), scientific partners, high tech industry to colocate resulting in higher job growth and increased productivity.

The concept includes a graduate institute, innovation incubator and technology park. Looking ahead, the government want to increase accessibility through improved transport connectivity with the ANSTO facility for workers and overall Greater Sydney. This will also require additional infrastructure to support the innovation precinct.




Figure 2: ANSTO Collaboration Area





Education and Health Precincts

The State Government acknowledges Education and Health Precincts provide important services and employment for the local community. By encouraging continued growth there is an opportunity to attract more specialised skilled workforce to the region.

Kogarah

The Kogarah Health and Education Precinct predominately services Bayside and Georges River LGA's and forms part of the South Easter Sydney Local Health District (LHD). The region is a major health hub with the Plan identifying half of jobs are based in the healthcare and social assistance sector.

The South District Plan (pg.. 59) states the objectives for this Collaboration Area are to:



Prioritise land use to grow existing and new allied health and education services.



Increase knowledge-based and population serving employment.



Provide affordable housing for students, moderate income households and health visitors.



Investigate opportunities to improve connections within the precinct and Greater Sydney.

Bankstown-Lidcombe

The Bankstown-Lidcombe Health and Education Precinct is still growing, and it is anticipated the Bankstown-Lidcombe Hospital will continue to be a catalyst for other health and education complementary services to co-locate within the precinct. Infrastructure improvements in the Sydney Metro City and Southwest will also boost the appeal of the region for residents and healthcare providers to relocate. The South District Plan (pg.. 60) states the objectives for this Collaboration Area are to:



Identify locations for the key facilities and create opportunities for allied health and education services to locate in the precinct.



Provide affordable housing for students, moderate income households and health visitors.



Improve accessibility and connections to public transport network.





Bankstown Airport and Milperra Industrial Area

The Bankstown Airport is recongised as a trade gateway for the region and mainly provides general aviation, parcel freight and recreational flying services. Over the next 20 years, the role and capacity of Bankstown Airport is expected to increase due to the flow on impact of Western Sydney Airport and Badgerys Creek Aerotropolis.

Milperra Industrial Area Bankstown Airport is a major employment centre in the South District accommodating approximately 15,700 workers.

The Plan identifies growth in this region will continue to be supported as an industrial and employment hub for the South District due to access to road, rail and air transport.

According to The Bankstown Airport Masterplan 2014, approximately 130 hectares has been allocated to facilitate growth of non-aviation indicating there is still considerable growth to occur in this area over the coming years.

The South District Plan (pg., 60) states the objectives for this Collaboration Area are:



Improve transport connections to the broader District.



Integrate planning for the airport with planning of surrounding lands.




Coordinate infrastructure delivery.



Facilitate advanced manufacturing and innovation.



Expand opportunities stemming from Western Sydney University Bankstown Campus and the University of NSW Aviation School.

Strategic Centres

Strategic Centres are key for the local community providing employment, goods and services, transport and housing and help achieve the goal of a 30-minute city. Across the South District, the Strategic Centres Campsie, include Bankstown, Hurstville, Kogarah, Miranda and Sutherland. The Plan (pg.. 62) states strategic centres are generally characterised by the following factors:

1 in 5 jobs based in Strategic Centres in the South District.



High levels of private sector investment.



Flexibility, so that the private sector can choose where and when to invest.



Co-location of a wide mix of activities, 🅯 including residential.



High levels of amenity, walkability and being cycle-friendly.



Areas identified for commercial uses and, where appropriate, commercial.

The Plan stipulates (pg. 62) "employment growth is the principal underlying economic goal for metropolitan and strategic centres" coupled with the impact of COVID-19, there may be some upward pressure on demand for suburban office locations that allow people to work closer to home from satellite offices. One of the key challenges will be ensuring sufficient development of commercial space and residential/mixed use buildings that will support future growth of the community. With new development potentially attracting new business opportunities and boosting population growth there may new prospects unlocked for health service providers in these strategic centres to cater for growing demand.
